Text: *Network Flows: Theory, Algorithms and Applications*, by Ravindra K. Ahuja, Thomas L. Magnanti and James B. Orlin, published by Prentice Hall 1993.

Course Description: This course is about modeling, solving and understanding *network flow problems*. Such problems arise naturally in many disciplines such as telecommunications, transportation, electronic circuitry, wataer distribution. In addition, they can be used to solve many problems where the connection with networks is not immediately obvious. A network formulation can provide a clear visual representation of the problem enable efficient solutions methods. There are three general topic areas covered in this course: Modeling and understanding network application areas, algorithmic development of network algorithms including proofs of correctness of such algorithms and computational measurements of “goodness” for such algorithms. The study of network flows involves concepts from optimization, complexity theory, and data structures.

Software: You will be expected to use a software package called GIDEN. You can download this software from: <http://giden.northwestern.edu/> You will also be using a software package called MPL which can be obtained by going to <http://www.maximalsoftware.com> and downloading the student version of the software. Both software packages are free.

Main Goals:

Enable one to formulate optimization problems as networks and graphs (i.e. as collections of nodes and arcs with information about any restrictions on flow, any side constraints, and other data-related issues and be able to specify an appropriate objective function)

Learn the terminology of graph theory and cover the fundamental algorithmic ideas for solving the main categories of network flow problems.

Identify what makes an algorithm computationally efficient

Understand simple algorithms for searching, topological ordering and decomposing flows on networks

Navigate data structures used to represent network algorithms on computers

Be able to solve efficiently shortest path, maximum flow, minimum cost flow, minimal spanning tree, assignment and matching problems.

Be able to identify when alternative algorithms for each problem is likely to be most efficient.

Homework and Grading:

Homework problems will be assigned each week. Some or all of the assignments will be collected and graded.

There will be one in-class midterm exam and the final will also be in class. All exams will be open book and open notes.

Grades will be computed as follows:

- 30% homework
- 30% midterm
- 35% final (20/15 take home and in-class)
